## Membership

Member, on signing:

- a- acknowledges his or her sharing of the PMA's believed, understood and accepted principles of
  - i- bodily autonomy and sovereignty of each individual over his or her matters of health and disease,
  - ii- the body's natural and God given intelligence and healing mechanisms, the healing system, as processes that come from within and cannot be given from outside the self but, from outside, can only be assisted, facilitated or supported,
- b- demonstrates a desire to work within the PMA's framework, finding a place where liberty minded members can exercise their inalienable rights and constitutionally given freedoms of speech, religion, assembly, and private business, in order to seek from other members healthcare advise, products, technologies and interventions at their discretion, of their own free will and with their fully informed consent, and do so without interference from government regulating offices,
- c- has read, questioned if so desired, received satisfactory answers from other members and understood this agreement in full,
- d- agrees to pay in full the membership fee of either a **monthly \$30 US dollars or equivalent** in other currency, or a **yearly \$220 US dollars or equivalent in other currency**, due at the time of signing and
- e- receives access to all membership privileges that include:
  - i- access to the Members Only section of the PMA's website and physical locations,
  - ii- the ability to contract with Dr. Gaston Cornu Labat for healthcare consultations and or any other offered services and products within the framework of this PMA,
  - iii- the ability to contract with any other Member who offers services within the framework of this PMA,
  - iv- access to Special Events sponsored by the PMA, which may or may not carry an extra cost beyond the membership dues, and which carry also the option of a limited time or single-event membership,
  - v- access to all educational and healthcare materials and programs, and other resources available

- vii- access to our periodic live events/webinars with interaction, pertaining to healthcare and current events.

Other privileges may be added at any time with corresponding notice to Member. Any and all membership privileges obtained through this agreement may be revoked or changed at any time with prior notice to Member.

At any point during this contract, if other levels of membership become available, the Member can change his or her membership status with prior notice to the PMA. If cost increase occurs during membership change, the member will be responsible for costs incurred.

Member agrees he or she meets all membership requirements and will notify the PMA if any requirements are not met during the time of the agreement term. Member shall receive a copy of the Articles of Association for the PMA upon completion of this agreement's signing.

### **Records and Confidentiality**

Member acknowledges and agrees that all documents and records exchanged between and maintained by the signing individuals to this agreement are privileged communications, are not medical records, and are not to be disclosed other than in compliance with standards for such privileged communications in the jurisdiction where services are provided.

### **Term and Termination**

This Agreement's term is unlimited unless otherwise specified and shall remain in effect until one or more of the following occur:

- Member fails to meet any requirements of membership.
- A specified Agreement term lapses without further terms or agreements added.
- SIGMA-health U project PMA permanently shuts down.

All terms and conditions of this agreement intended to protect the signing living men and women and their records, and regulate disagreements between them shall survive any termination.

### **Complaints and Grievances**

All members acknowledge and agree that complaints and grievances relating to any and all aspects of the PMA and services provided under its framework shall be addressed and resolved through PMA's administrative process. For such process, complaints and grievances shall be reported to the Governing Body. Within the Governing Body, an uninvolved member will mediate communication between the grieving parties, exercising best effort and candid and constructive communication, to establish merit and resolution of said complaint or grievance. If this mediation fails, the sole recourse shall be resolution through arbitration mutually agreed upon by involved members, and the decision pursuant to arbitration shall be final and binding.
